66 CLUB RULING/APEAL.

The Director was called to a table during the 66 Club played on Sunday 7th February 2016:

When I was called the bidding had not finished. I told the players to finish the bidding and that I would review the auction.

After some consideration I determined that the bid could stand but I also decided to seek the input of two other directors. As they were both playing this had to wait to the end of the session. Seeking advice from experienced players is a common practice.

At sessions end I approached Andrew Smith and Jeff Carberry (Chief Tournament Director) for their input.

After discussion it was decided that my initial decision would be upheld.

I announced the winners but stated that this was subject to appeal. The non-offending pair had actually left the room and gone home.

At the next session (Monday night) I approached one of the players and told him of my decision and their right of appeal. I mentioned that I was fairly certain that there was a time limit on the appeal and that that had expired but that the player could discuss it with his partner and get back to me. Subsequent to this the pair decided to appeal my decision.

Since then I have revisited the the IBA Tournament Rules which follow the NSWBA Tournament rules:

B. FORM AND TIME OF APEAL

3.3 *An appeal must be lodged within the time specified in the Supplementary*

Regulations. In the absence of such specification, the following time limits apply.

a) *In the course of a multi-session event the time for lodging an appeal is prior*

to the commencement of the next session.

b) *In the case of a single session event or the last session of a multi-session event or match, (Law 92B) the time is 30 minutes after the official score has*

been made available for inspection. (The Director should ensure that this time is displayed.)

c) *Appeals relating to scores must be lodged within the above time limits or 30 minutes after a ruling is made and announced, whichever is the later.*

As a consequence I find that the appeal is invalid and can announce that the winners of the 66Club for this year are Liz and Steve Hurley.

I apologise for not knowing clearly the laws and my attempt to try to be fair to all parties was not allowed by LAW! Laws are there for very good reasons – to prevent stuff ups like this!

The following advice was given to IBA Directors last year

The hesitation has given partner unauthorised

information. The Director needs to determine whether partner has acted on this unauthorised information.

1. **Hesitations-** Hesitations are often the cause of much angst at the table – determine what happened – often getting the player to admit that they had “a little think” and bid out of tempo is the hard part! Remember to assure the players that thinking is an important part of bridge! However there are rules that need to be followed.

the following is taken from the South African Bridge Association and the ACBL

1. Bids made after a hesitation by partner, especially when the hesitation is followed by a pass, may be construed as having been influenced by the hesitation. The partner of the player who hesitated should, in such a circumstance, ensure that they have full values for their call because a marginal call may be construed as having been influenced by partner’s hesitation.
2. Players in this situation are required by the Laws not to choose from among logical alternatives one that could demonstrably have been suggested over another by the extraneous information (Law 16B and Law 73C).
3. Failure to follow this practice may be judged by a Director as having been influenced by the hesitation.
4. NOTE THAT A hesitation is seldom an infraction of the Law and a bid by the partner of the player who has hesitated might be perfectly legal.
5. Opponents should refrain from calling a Tournament Director until such time as it appears that they may have been prejudiced by the call following the hesitation and no later than the end of play of the hand.
6. Players may reserve their rights during the course of a hand, but it is not necessary to call a Tournament Director for this purpose unless there is a dispute at the table. Players do not have the right to ask a Tournament Director to make any ruling until after the play of the hand is completed and a Tournament Director

must not comment on the hand until then.

7. Any such adjustment will only be made within the Law 79C correction period. If subsequent to the irregularity, the non-offending side has contributed to its own damage, the provisions of Law 12C 1 B will be

1. **The director’s first responsibility is to establish the fact that a hesitation did in fact take place.** When the director is called to the table during the auction and it is reported that an undue hesitation has occurred.

2. **Next, the director should advise the partner of the hesitator what is expected:**

Example: The partner is not to take advantage of information gained by the out-of-tempo action, but to make any clear-cut calls that would have been made.

3. **The director then should order the auction to proceed.**

4. **Directors should not make a ruling until the conclusion of play,** at which time they will either allow the result to stand or assign an adjusted score. They should clearly state, “My ruling is ...” to avoid uncertainty as to his decision.

The best way to handle this ruling is to tell players to temporarily record the score achieved at the table, making it clear that you have not yet made a decision. Then return with your ruling to both pairs a round or two later. Tempers will not be as frayed, and the players will be more inclined to listen to your ruling. They will also feel that you have devoted time to consider the case.

I determined that even with North’s hesitation South’s 5D bid was justified. It was a strong playing hand with little defensive values. EW had limited their hands and were not looking for slam so South could rely on partner for some points. NS were not vulnerable.
