As everyone knows NSWHealth took over our Figtree premises for COVID testing early in 2021. We wanted to hold our congress face-to-face but could not guarantee that we would meet COVID restrictions so we went looking for a venue that could accommodate us. We therefore booked The Fraternity Club where 30 tables would fit in the upstairs ballroom area. Due to the COVID-19 lockdown in Victoria and the postponement of the VCC (Victor Champion Cup) we were inundated with entries from many very experienced bridge players.

What an experience for us all, to be able to test our skills against some of the best bridge players in Australia. I think we should all be proud of the efforts of our IBA players over the two days.

### **3 Other recent results**

#### *a) NSW Country teams*

Ten teams battled out the Tablelands-Illawarra Regional final in the NSW Country Teams. Three Illawarra teams took part and put up a great show for the IBA. There were also three teams from the Highlands club, two from Bowral and two from Nowra. Ian Lisle was the director and took the precaution of ensuring all the teams from the same club played each other in the first couple of rounds in to avoid controversy later in the day.

**Illawarra 1** lost their first match to **Illawarra 2** by 10imps but then played solidly to be leading the field after 8 rounds. According to the Director, the last match was exciting as the results of the last 6 boards came in as several changes of the overall lead occurred. Illawarra 1 held on though and ended up winning by 2.6 VPs. **Illawarra 3** also finished creditably, in the top half of the field, after an enjoyable day for all.

#### *b) ABF Nationwide Pairs – Sunday July 25th*

Since May last year, as the impact of Covid became clear, the ABF introduced the Nationwide Pairs Competition on the BBO platform. Our club has had many notable results in these events. However, on Sunday July 25<sup>th</sup> we truly hit the Jackpot with several pairs excelling across all 3 Divisions (Open, Restricted and Novice).

The Open competition featured 39 tables and here, Martin Bunder and Tony Wright finished 4<sup>th</sup> EW, Walt Davis and Jeff Carberry finished 6<sup>th</sup> NS with Ruth Neild and Rilla England 7<sup>th</sup> NS. A special mention goes to Carol Jeffs and Jennette Rosetta for their 12<sup>th</sup> place finish.

In the restricted event, with 25 tables, Pranati Basu and Maria Christensen finished 4<sup>th</sup> EW with Sue Bochan and Moira Cunningham in 8<sup>th</sup>.

The Novice event attracted 30 tables and here, Edith and Ron McNally finished 1st with an excellent 64.9%.

Great work by all, well done.

## **4 President's Report - Jill Macrae**

Jill Macrae has put together a timeline of events since the Covid epidemic began.

1. The IBA closed its doors on 16<sup>th</sup> March 2020 due to the Covid 19 pandemic.
2. On 20<sup>th</sup> May 2020 the directors began 2 virtual sessions on BBO. These sessions were well attended by about 50% of club members over the following almost 12 months. Many members played regularly in other online competitions including the ABF Nationwide Pairs events.
3. Wednesday 14<sup>th</sup> April 2021 following transfer of tables, scoring equipment and sanitising gear, the club held its first session at the local HELENIC CLUB with 11.5 tables. Our own premises had been usurped by NSW Health for a Covid testing clinic.

4. Under pressure from stakeholders the Council and NSW arranged for the IBA to return to the club rooms. This was followed by frantic transfer of equipment.
5. The first session of face-to-face Bridge was held in the Figtree Community Hall on Monday 17<sup>th</sup> May 2021. All the usual club sessions restarted.
6. Evening sessions numbers were generally small.
7. Friday 7<sup>th</sup> May we began a new online session on BBO for players who were not willing to return face to face.
8. The Northern Branch of IBA began face to face bridge with a Wednesday session on 7<sup>th</sup> April 2021.
9. Lessons continued for TAMS players and other beginners through the lockdown. A zoom lesson on Tuesday followed by play on Thursday. BBO teaching table was used for those in the middle of beginner lessons with general tables for other members. As a result of this, the club has endorsed several new members who graduated from the 2020 intro class. We have also attracted several other players as new members, including 5 from other online lessons (notably Paul Marston). 19 new members in total.
10. Most of our members paid their annual membership fees for 2021.
11. The club held its Annual Congress at the new venue of the Fraternity Club Fairy Meadow, on Saturday 11<sup>th</sup> and Sunday 12<sup>th</sup> June.
12. We kept up payments for utilities at Figtree, rent at Thirroul, payments for security including John, who keeps us safe at night. We collected no revenue when we played at the Hellenic club but received funds for the 'virtual club' from BBO.
13. On Saturday 26<sup>th</sup> June, the NSW State Government announced that a new period of lockdown would commence at midnight, and since then, we have returned to online sessions.
14. During the period of face-to-face bridge from 7<sup>th</sup> April until 26<sup>th</sup> June we had begun to collect table fees online, details of payment options are given below. However, while records of deposits and sessions played have been kept, privacy issues have restricted efficient reporting of balances to members. We would therefore like to ask that you review sessions you played and money you paid to ensure everything matches up, then making up any outstanding sum via the methods below. We would also be very grateful for advice on software that would enable the Treasurer to keep these records up to date in future. When we return to the clubrooms, we see this as a more efficient way of collecting table fees.
15. In the last week of July, the State Premier announced a further 4 weeks of an intensified period of lockdown. We will keep members abreast of developments as and when they occur.
16. We are aware that many members are unfamiliar with the intricacies of playing online, so if you haven't been playing and yet would like to 'have a go', please contact myself, or the Secretary, Carolyn Githens, to obtain a set of written instructions for you to follow.

## **5 Calling the Director – a perspective from Dave Havyatt**

The experience of attending a Directors Course at the NSW Bridge Association teaches a player a lot more than how to direct. The course I attended on 6 June was taught by Ian Lisle who has directed for us at the Illawarra when we hosted the State Novice and Restricted Teams in 2019 and occasionally plays at our club and played at our 2021 Chris Diment Memorial Congress.

As a bridge player we sometimes think that calling the Director is a bit like calling the police and that, as intelligent adults, we should be able to sort it out at the table. This is a poor understanding of the role of a Director.

The first and foremost role of the Director is making games, and the club, work well. It isn't just to be an expert on the Laws. If you don't call the Director they can't do their job of making the game work smoothly.

While we were playing online many of the most common circumstances for calling the Director couldn't occur; call out of turn, insufficient bid, lead out of turn and revokes. All of these require the Director to be called.

There are many occasions where even players at the table who fully understand the Laws cannot make a decision. Who at the table can determine if a bid made to replace an insufficient bid is a comparable call? Who at the table has the power to issue a corrected score if unauthorised information has been used?

Calling the Director at the moment there is an infraction is the best way to deal with any circumstance. If you call the Director, you are not accusing your opponents of anything, you are just ensuring the hand can be played and scored fairly.

Finally, just an observation. The Directors have fairly good hearing, so the call need not be excessively loud, but they do need to be able to find the right table. So please leave a hand raised so the Director doesn't have to make a second disturbance asking where the call came from.

## **6 IBAND – Barbara Overington**

During our all too brief period of face-to-face bridge, sessions at our Northern Branch were run through May and June. This was not an easy proposition, with many players wanting to play, many needing a partner, and a seven table (Covid) restriction at the Thirroul Railway Institute Preservation Society (TRIPS) Hall. Sessions were run on Monday mornings, Wednesday evenings and Friday afternoons until 25<sup>th</sup> June. Fridays were often over-subscribed and booking via email needed to be made. If the seven-table limit was exceeded, pairs that missed out one week were placed at the top of the booking list for the following week. There were no supervised sessions during this period.

Note: Our special thanks go to both Barbara Overington and Rob Mathie for their Herculean efforts in providing regular bridge sessions for members at our Northern Branch.
